The above placements shall be subject to the following conditions:

- a. That these arrangements shall be an interim one, purely temporary in nature, without conferring any preferential right to any of these Engineers to claim substantive promotion/regularization/ confirmation, which shall be made strictly as per the Recruitment Rules and as per other eligibility conditions prescribed thereof through DPC/ J&K PSC.*
- b. That these arrangements shall be subject to the outcome of writ petition(s) pending, if any, before any Competent Court(s) of law.*
- c. The arrangement shall be reversible without any prior notice to any of these Engineers, if any adverse report is received from any agency against them and any superior claim of any left-out Engineer of the relevant quota, if found genuine, later on.*

Further, in terms of Government Order No. 34-JK(DMRRR) of 2022 dated 22.06.2022, issued by the Department of Relief, Rehabilitation and Reconstruction, read with OM No. FD-Code/132/2022-03-1074 dated 28.06.2022, issued by the Finance Department, sanction is hereby accorded to the creation of 12 supernumerary posts of Assistant Executive Engineer in Pay Level-10A [56600-179800] in the personal capacity of the above-mentioned engineers, for effecting promotion with subsequent abolition of the supernumerary post of Assistant Engineer held by them. However, the actual date of creation and abolition of posts shall be as per the date of regularization to be considered by the DPC/ J&K PSC.

Consequent upon the above placements, these engineers shall continue at their present places of posting, till further orders.
